Introduction:

The Ministry of Transport and Communications (MOTC) implements sector reforms to improve the maintenance of roads under its jurisdiction and ensure sufficient financing of the maintenance. MOTC needs for a qualified lawyer to assist in developing a legal framework of sector reforms, particularly, to support the Cabinet of Ministers' decree on the establishment of the Road Fund and State-Owned Enterprise "Kyrgyzavtozhol".

- The Lawyer's activity shall be coordinated, and his/her detailed schedule of works approved by the Minister and supervising Deputy Minister of MOTC within 10 days from the beginning of the assignment; the schedule may be adjusted as instructed by the Deputy Minister;

Specific tasks:

- development and approval of legal acts and documents (Charter, constituent documents, minutes, orders, etc.) of the reorganized entities;
- carry out measures for the official registration of newly created entities;
- legal support and advice to the Working Commission on reorganization, including the preparation and maintenance of all working documentation.
- analysis of existing internal documents of the DDH (Road Maintenance Department of MOTC) work organization and assistance in optimization;
- development of recommendations on the staff number, taking into account the assigned functions for newly created enterprises.

Outputs:

- a package of constituent documents registered with the judicial authorities;
- packages of documents for registration;
- working documentation (minutes, decisions, acts, etc.) on the activities of the Working Commission.

Reporting requirements:

Initial report - a schedule and sequence of works shall be provided after 10 days, with a clearly indicated planned timing for the fulfillment of assignments; (information on the progress shall be provided on a monthly basis);

Monthly progress reports shall be submitted to the supervising Deputy Minister.

Completion report - complete information on the tasks accomplished and achievements with recommendations for further activities with regard to the adopted documents.
